## **COMMITTEE REPORTS**

**LEGISLATIVE:** NRA and Democratic leadership have agreed upon verbiage regarding mental health background checks and gun ownership.

Chuck Lacher reported on rendezvous between Ellensburg and Cle Elum (at Mike Jensen's) for the weekend of June 16 – 17, being hosted by the Interlake Mountain Men. Also, Pacific Primitive Rendezvous begins this weekend also, in John Day, Oregon. Lee asked permission to distribute gun show flyers at the Pacific Primitive Rendezvous, with the admission price "blacked out." OK'ed by membership.

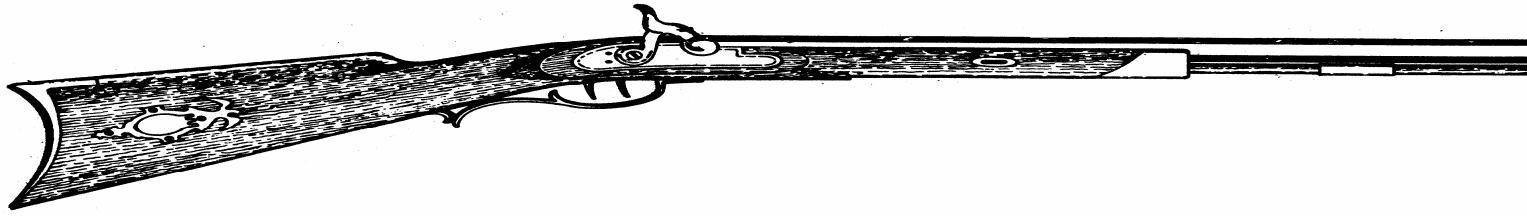
